

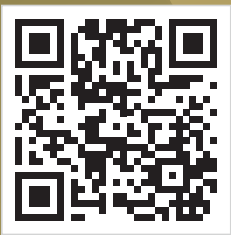

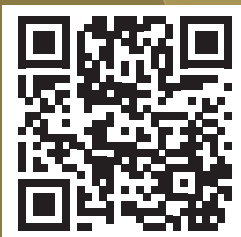

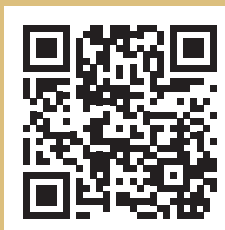

# APPLICATION GUIDELINES

The EGPES Energy Awards are your opportunity to spotlight groundbreaking innovations and leadership in energy. Showcase your achievements in sustainability, innovation, and excellence, shaping the future of the industry.

Guided by an esteemed jury, the evaluation process ensures impartiality and rigor, culminating in the announcement of winners and highly commended recipients during the Awards Ceremony on Tuesday 18 February 2025.

## IMPORTANT INFORMATION

- Nominations to be submitted by a company representative.
- Any company can submit multiple entries.
- These are yearly awards, and the 2025 edition will recognise projects completed within 2024-2025.
- The Jury will only consider projects that have already been completed (i.e. not ideas or suggestions).
- All entries should be submitted in written English. Any entry submitted in a different language will not be considered.
- Please do not submit the same entry more than once. If an entry is submitted multiple times, the most recent entry will be considered, with previous entries being deleted.
- There are no associated fees to submit entries/submissions process.

## SUPPORTING DOCUMENTS REQUIRED

### MANDATORY

Entries must be submitted in a PowerPoint presentation format (max. 10 slides) and should include a detailed project overview or individual profile (for the Young Energy Professional of the Year category), an explanation of how the project or individual aligns with the evaluation criteria (Impact, Innovation, Delivery Excellence, Scalability), and a concise summary outlining why the project or individual deserves recognition. The PowerPoint template is available for download at [egypes.com/awards](http://egypes.com/awards).

### OPTIONAL

Participants can enhance their submissions with supporting materials such as recommendation letters from stakeholders or clients, published articles or media coverage, evidence of other awards or recognition, and any relevant visuals (e.g., photos, charts, or infographics) that help support the submission. All supporting documentation should relate to activities or achievements from 2024–2025.

# EVALUATION CRITERIA

## IMPACT & OUTCOMES (50%)

Evaluate how the project or individual initiative has achieved measurable results. Depending on the category, examples include:

### BREAKTHROUGH PROJECTS

Contributions to the energy transition through decarbonisation, energy efficiency, hydrogen innovation, or other transformative technologies.

### HEALTH AND SAFETY INITIATIVES

Tangible improvements in worker safety, environmental protection, or community well-being across the energy value chain.

### OPERATIONAL EXCELLENCE

Demonstrated process optimisation, cost reduction, enhanced reliability, and sustainability in operational performance.

### YOUNG ENERGY PROFESSIONALS

Clear evidence of innovation, leadership, and impactful contributions to projects driving change in the industry. Provide quantitative and qualitative data to illustrate the outcomes before and after implementation.

## INNOVATION & ORIGINALITY (20%)

Highlight the originality of the project or individual initiative. Examples include:

- Nominations to be submitted by a company representative.
- Creative approaches to solving industry challenges in health and safety, operations, or sustainability
- Creative approaches to solving industry challenges in health and safety, operations, or sustainability
- Novel strategies or solutions introduced by young professionals to drive change and inspire the industry.

## DELIVERY EXCELLENCE (20%)

Assess how well the project or initiative was executed. Key considerations include:

- Completion within the expected timeline and budget.
- Achievement of initial goals or surpassing expectations.
- Challenges encountered during implementation and how they were overcome.

## SCALABILITY AND INDUSTRY IMPACT (10%)

Evaluate the potential for the project or initiative to be scaled or replicated across the energy sector. Examples include:

- Projects that can serve as a benchmark or best practice for the industry.
- Young professionals or innovative initiatives that inspire others and encourage widespread adoption of new ideas

# AWARDS JURY EVALUATION PROCESS

# 1



## BEST BREAKTHROUGH PROJECT OF THE YEAR

### WHO CAN SUBMIT ENTRIES

Entries can be submitted by companies, organisations, or individuals that have delivered innovative projects in clean energy technologies, decarbonization, energy efficiency, methane reduction, or hydrogen innovation. Eligible participants include national and international oil, gas, and energy companies, EPC contractors, technology providers, and startups pushing the boundaries of energy transition. Submissions may be made directly by the organisation or by a representative on behalf of the project. Projects must demonstrate measurable and transformative impacts completed within the qualifying period of 2025–2024.

### SUPPORTING DOCUMENTS REQUIRED

#### MANDATORY

A detailed PowerPoint presentation (maximum 10 slides) that includes:

- An overview of the breakthrough project, including its objectives and implementation timeline.
- A clear explanation of how the project aligns with the evaluation criteria, addressing measurable impact, innovation, quality of delivery, and transferability.
- A summary highlighting why the project deserves recognition in this category.
- Proof of project completion within the qualifying period (2024–2025). This may include project reports, official declarations, or other verifiable documents.

#### OPTIONAL

- Letters of recommendation from stakeholders, clients, or industry leaders supporting the project's success.
- Articles, interviews, or publications that showcase the project's achievements.
- Evidence of previous awards or recognition related to the project or its outcomes.

### COVER LETTER CONTENT

The cover letter must summarise the essence of the breakthrough project and articulate why it merits recognition. It should be tailored to highlight:

#### INNOVATION AND ORIGINALITY

- Explain how the project introduces groundbreaking solutions in clean energy technologies, decarbonisation, or other relevant areas. Highlight the uniqueness of the approach or technology used.

#### IMPACT AND OUTCOMES

- Outline measurable results, such as reductions in greenhouse gas emissions, improved energy efficiency metrics, or advancements in clean energy production. Quantify the before-and-after scenario wherever possible.

#### ALIGNMENT WITH INDUSTRY GOALS

- Emphasise how the project addresses critical challenges in energy transition and supports global sustainability goals.

#### SCALABILITY AND REPLICABILITY

- Discuss the potential for the project to be replicated or scaled in other regions or contexts, contributing to industry-wide best practices.

#### TEAMWORK AND LEADERSHIP

- Briefly acknowledge the team's role in conceptualising and executing the project, showcasing collaboration and leadership.

## 2



**OPERATIONAL EXCELLENCE  
PROJECT OF THE YEAR**

### WHO CAN SUBMIT ENTRIES

Entries are invited from companies, organisations, or individuals that have implemented projects optimising operations and enhancing efficiency across the energy value chain. Eligible participants include national and international oil, gas, and energy companies, EPC contractors, service providers, and technology innovators. Projects submitted should demonstrate measurable improvements in process optimisation, cost reduction, reliability, and sustainability. Submissions may be made directly by the organisation or by a representative on behalf of the project. All entries must pertain to initiatives completed or operational during the qualifying period of 2025–2024.

### SUPPORTING DOCUMENTS REQUIRED

#### MANDATORY

A detailed PowerPoint presentation (maximum 10 slides) that includes:

- A comprehensive description of the project, including objectives, scope, and implementation timeline.
- Details on how the project achieved operational excellence, aligned with evaluation criteria such as measurable impact, innovation, and sustainability.
- A summary highlighting why the project deserves recognition under this category
- Proof of project implementation within the qualifying period (2024–2025). This may include performance reports, official documentation, or verifiable results showcasing operational success.

#### OPTIONAL

- Testimonials from stakeholders, partners, or clients endorsing the project's achievements.
- Articles, publications, or case studies demonstrating the project's impact on operational efficiency.
- Evidence of previous accolades or industry recognition linked to the project.

### COVER LETTER CONTENT

The cover letter must provide a compelling narrative explaining the significance of the project and why it deserves recognition. It should include:

#### OPTIMISATION AND EFFICIENCY

- Highlight how the project has streamlined operations, reduced costs, improved resource utilization, or enhanced system reliability.

#### MEASURABLE IMPACT

- Share specific outcomes and key performance indicators, such as reduced operational costs, energy savings, or increased throughput, substantiating the project's impact.

#### SUSTAINABILITY AND ALIGNMENT

- Explain how the project aligns with industry sustainability goals, showcasing contributions to environmental, social, and governance (ESG) objectives.

#### INNOVATION AND CREATIVITY

- Illustrate innovative strategies, technologies, or methods used to achieve operational excellence.

#### TEAMWORK AND LEADERSHIP

- Acknowledge the role of the team and leadership in driving the project to success, emphasising collaboration and expertise.

## BEST HEALTH AND SAFETY PROJECT OF THE YEAR

### WHO CAN SUBMIT ENTRIES

Entries are open to companies, organisations, or individuals across the energy value chain that have implemented impactful health and safety initiatives. Eligible participants include national and international oil, gas, and energy companies, EPC contractors, service providers, and technology innovators. Projects must demonstrate a significant contribution to enhancing safety standards, minimising risks, and protecting worker and community well-being. Submissions can be made directly by the organization or on behalf of the project. All entries must be related to initiatives operational or completed during the qualifying period of 2025–2024.

### SUPPORTING DOCUMENTS REQUIRED

#### MANDATORY

A detailed PowerPoint presentation (maximum 10 slides) that includes:

- A comprehensive description of the project, including objectives, scope, and implementation timeline.
- Details on how the initiative improved health and safety outcomes, aligned with evaluation criteria such as measurable impact, innovation, and adherence to safety standards.
- A summary outlining why the project deserves recognition in this category.
- Proof of project implementation during the qualifying period (2024–2025). This may include safety performance reports, certifications, or documented evidence of enhanced safety practices.

#### OPTIONAL

- Testimonials from employees, stakeholders, or communities benefiting from the initiative.
- Articles, case studies, or publications highlighting the initiative's success in improving health and safety.
- Evidence of previous awards or recognition associated with the project.

### COVER LETTER CONTENT

The cover letter must provide a compelling narrative explaining the significance of the project and why it deserves recognition. It should include:

#### HEALTH AND SAFETY IMPACT

- Highlight measurable improvements, such as reduced incidents, enhanced safety protocols, or improved employee well-being, backed by specific metrics.

#### INNOVATION AND BEST PRACTICES

- Describe innovative approaches, technologies, or methods implemented to achieve superior health and safety outcomes.

#### INDUSTRY ALIGNMENT AND STANDARDS

- Explain how the initiative aligns with global health and safety standards and addresses industry-specific risks and challenges.

#### COMMUNITY AND WORKFORCE ENGAGEMENT

- Showcase the initiative's contributions to creating a safer environment for employees, contractors, and the wider community.

#### TEAM LEADERSHIP AND COLLABORATION

- Acknowledge the team and leadership efforts in successfully implementing the health and safety initiative.

# 4



**YOUNG ENERGY PROFESSIONAL  
OF THE YEAR**

## WHO CAN SUBMIT ENTRIES

This category is open to individuals under the age of 35 (as of 31 December 2024) working in the energy industry who have demonstrated exceptional leadership, innovation, and contributions to impactful projects. Eligible participants include professionals from national and international oil, gas, and energy companies, EPC contractors, service providers, and technology providers. Nominations can be self-submitted or submitted by colleagues, supervisors, or company representatives. Candidates must demonstrate a track record of excellence and innovation during the qualifying period of 2023–2024.

## SUPPORTING DOCUMENTS REQUIRED

### MANDATORY

A detailed resume or CV outlining the candidate's professional experience, education, and achievements. A PowerPoint presentation (maximum 15 slides) that includes:

- An overview of the candidate's key projects, responsibilities, and accomplishments.
- Evidence of their impact on the organization, project outcomes, or the industry at large.
- A summary of why the nominee is deserving of this award.
- Proof of age (e.g., a government-issued ID or passport).

### OPTIONAL

- Letters of recommendation from supervisors, colleagues, or clients highlighting the nominee's achievements and contributions.
- Media coverage, articles, or publications featuring the nominee's work or impact.
- Certificates or documentation of relevant awards, recognitions, or training programs completed.

## COVER LETTER CONTENT

The cover letter must provide a compelling narrative explaining the significance of the project and why it deserves recognition. It should include:

### LEADERSHIP AND INNOVATION

- Outline how the nominee has demonstrated leadership qualities, innovative thinking, and a proactive approach to challenges in the energy industry.

### IMPACT ON PROJECTS AND TEAMS

- Highlight specific examples of how the nominee has contributed to the success of key projects or initiatives, showcasing measurable results where applicable.

### ALIGNMENT WITH INDUSTRY GOALS

- Emphasise how the nominee's work aligns with broader industry objectives, such as sustainability, efficiency, or energy transition.

### VISION AND FUTURE POTENTIAL

- Discuss the nominee's aspirations and potential to shape the future of the energy industry, including how they inspire and empower others.

### COMMITMENT TO EXCELLENCE

- Acknowledge the nominee's dedication to continuous learning, ethical practices, and fostering a positive impact within their organisation and beyond.





# FREQUENTLY ASKED QUESTIONS

## Who can submit an entry?

EGYPES Energy Awards are open to all individuals and companies in the energy value chain, meeting the criteria of the related category/categories. We welcome entries from across the globe. Self-nominated and third-party entries are both accepted. There are no limits to how many unique submissions can be made by an individual or company if the eligibility requirements for the category are met. If a project is relevant to multiple categories and corresponds with the entry submission criteria, it may be submitted for multiple categories.

## Can I submit multiple entries for the same project in the same category?

No. If the same entry is submitted multiple times, the most recent entry will be considered, with previous entries being deleted.

## What category should I nominate my company for?

You can contact us at any time within the entry submission period to get category recommendations or help with your entry. Email us at [awards@egypes.com](mailto:awards@egypes.com).

## Are joint submissions between multiple companies allowed?

Yes, please specify all company names under 'submission entry details' while submitting your entry.

## Are there any entry fees associated with the entry submission?

No. The EGYPEs Energy Awards are free to enter, irrespective of the number of categories you participate in.

## When is the deadline to submit entries?

All entries must be submitted via the EGYPEs Energy Awards online portal by 11:59 pm GST - Friday, 17 January.

## What format should the attachments be in?

Attachments are accepted in jpg, jpeg, gif, png, pdf, doc, docx, mp4, m4v, tiff, tif format. The maximum upload size is 200MB.

## Can I withdraw an entry?

Written requests for entry withdrawal are permissible before the finalists are announced.

## When will the finalists be announced?

The finalists for EGYPEs Energy Awards will be announced on Friday 31 January 2025.

## How do I submit my entry for the 2025 EGYPEs Energy Awards?

- Register and create your account on the online portal through the EGYPEs Awards webpage: [egypes.com/awards](http://egypes.com/awards)
- Choose the category or categories you wish to enter, complete all required fields against the judging criteria, and submit your entry.
- What are the entry submission guidelines?
- Entries will only be accepted through the online platform, [egypes.com/awards](http://egypes.com/awards).
- Ensure that you have read and understood the judging criteria, addressing the points provided in each section. It is important to be comprehensive and concise in your descriptions, including only the key information.
- Including evidence such as photos, graphs, press releases, media coverage, videos, etc., will strengthen the submission. These supporting materials should be added as weblinks and hyperlinks within the submission or uploaded directly to the online platform. Uploads must be of supporting images/graphs. Text-only uploads will not be accepted.
- Each entry is to be valid for the qualifying period between 2024 – 2025. If your entry is a resubmission, it is necessary to provide a project update for this period. Additional information must be available to support entries if requested.
- Please note that a company logo is required for all entries and must be in high resolution, in .eps or .ai format.

## Will I be notified if I have been selected as a finalist?

Yes. You will be notified by email by the EGYPEs Energy Awards team. You will also receive an email should you regrettably not make the shortlist.

## If I am selected as a finalist, is there a fee to attend the EGYPEs Awards ceremony?

Each category finalist will be given one complimentary invitation to attend the EGYPEs Energy Awards ceremony. Any travel or personal costs incurred to attend the ceremony are to be borne by the finalist.

## Is it mandatory for me to attend if I'm selected as a finalist?

It is not mandatory, however, we do encourage you to send a representative should your entry be awarded on stage.

## When will I know if I'm a winner?

The winners of each category will be announced at the EGYPEs Awards Ceremony, which will take place at the exhibition on Tuesday 18 February 2025 in the Egypt International Exhibition Center in Cairo, Egypt.
